

# Bulletin of Italian Geographical Society

Articles are refereed before publication.

This journal operates a double blind review process. All contributions will be initially assessed by the editor for suitability for the journal. Papers deemed suitable are then typically sent to a minimum of two independent expert reviewers to assess the scientific quality of the paper. The Editor is responsible for the final decision regarding acceptance or rejection of articles. The Editor's decision is final.

This journal uses double-blind review, which means the identities of the authors are concealed from the reviewers, and vice versa. To facilitate this, please include the following separately:

- Title page (with author details): This should include the title, authors' names, affiliations, acknowledgements and any Declaration of Interest statement, and a complete address for the corresponding author including an e-mail address.
- Blinded manuscript (no author details): The main body of the paper (including the references, figures, tables and any acknowledgements) should not include any identifying information, such as the authors' names or affiliations.

## GUIDE FOR AUTHORS

### FIRST STEPS

Before the submission of your manuscript to the Editorial Support ([bollettino@societageografica.it](mailto:bollettino@societageografica.it)) for peer review, you are kindly requested to:

- read the “Licence and copyright agreement for Bollettino della Società Geografica Italiana”;
- read the manuscript preparation for this journal;
- agree and comply with the “General obligations for authors”;

### SUBMISSION CHECKLIST

**Cover Letter.** A cover letter is mandatory and should give the justification of the submission, highlights of the article, and a general impact statement.

**Articles.** Full-length research manuscripts, consistent with the objectives of the Bulletin, are the main focus of the Journal. Regular articles should have a maximum total length of 50,000 characters including spaces. In general, a combined maximum of 8 normal-sized figures and/or tables is allowed (for instance 3 tables and 5 figures). For multiple-panel figures each set of two panels equates to one figure. Manuscripts can be submitted as a single Word or PDF file to be used in the refereeing process. Only when the paper is at the revision stage, the contributing author will you be requested to fit the paper into a “correct format” for acceptance and provide the items required for the publication of the article.

You can use this list to carry out a final check of your submission before you send it to the Journal for review. Please make sure that the following items are present:

#### Manuscript:

- Title (italian and english)
- Abstract (italian and english)
- up to 5 keywords immediately after the Abstract
- All figures (including figure captions)
- All tables (including titles, description and footnotes)

Make sure all figures and table citations in the text match the files provided

#### Further considerations:

- Manuscript should be “spell checked” and “grammar checked”
- All references mentioned in the Reference List must be cited in the text, and vice versa
- Permission to reproduce must be obtained for use of copyrighted material from other sources (including the Internet)
- Relevant declarations of interest are made
- Journal policies detailed in this guide were reviewed
- The author(s) can suggest up to 5 potential Referees and provide their current contact details. The editors of the Journal may or may not contact the suggested Referees.

**Referees.** Please submit, as part of the covering letter with the manuscript, the names, affiliation and email addresses of up to five potential Referees. Appropriate Referees should be knowledgeable about the subject but have no close connection with any of the authors. In addition, Referees should be from institutions other than (and possibly countries other than) those of any of the Authors.

Use of DOI is highly encouraged.

Note that missing data will be highlighted at proof stage for the author to correct.

Please, provide bibliographic references in texts, as it follows:

1 Author: Author year, page number/s (e.g. Smith 2005, 4-21)

2 Authors: Author 1, Author 2 year, page number/s (e.g. Smith, White 2005, 20)

3 or more Authors: Author 1 et al. year, page number/s (Smith et al. 2005, 33)

**Formatting requirements.** There are no strict formatting requirements but all manuscripts must contain the essential elements, for example Abstract, Keywords, Introduction, Materials and Methods, Results and Discussion, Conclusions, Acknowledgments, References, Artwork and Tables with Captions. If your article includes any Videos and/or other Supplementary material, this should be included in your initial submission for peer review purposes.

**Figures and tables embedded in text.** Please ensure the figures and the tables included in the single file are placed next to the relevant text in the manuscript, rather than at the bottom or the top of the file.

**Use of word processing software.** Regardless of the file format of the original submission, at revision you must provide us with an editable file of the entire article. Keep the layout of the text as simple as possible. Most formatting codes will be removed and replaced on processing the article. The electronic text should be prepared in a way very similar to that of conventional manuscripts. To avoid unnecessary errors you are strongly advised to use the “spell-check” and “grammar-check” functions of your word processor.

**Subdivision - numbered sections.** Divide your article into clearly defined and numbered sections. Subsections should be numbered 1.1 (then 1.1.1, 1.1.2, ...), 1.2, etc. (the abstract is not included in section numbering).

**Abstract** italian and english (no more than 1,500 characters including spaces). A concise and factual abstract is required. The abstract should state briefly the purpose of the research, the principal results and major conclusions. An abstract is often presented separately from the article, so it must be able to stand alone. For this reason, References should be avoided, but if essential, then cite the author(s) and year(s). Also, non-standard or uncommon abbreviations should be avoided, but if essential they must be defined at their first mention in the abstract itself.

**Keywords** italian and english (immediately after the abstract please provide up to five words avoiding general and plural terms and multiple concepts. Be sparing with abbreviations: only abbreviations firmly established in the field may be eligible). These keywords will be used for indexing purposes.

**Introduction** (state the objectives of the work and provide a strong and adequate background, avoiding a summary of the results).

**Materials and methods** (if applicable, provide sufficient detail to allow the work to be reproduced. Methods already published should be indicated by a reference: only relevant modifications should be described).

**Results and Discussion** (if applicable, should be clear and concise, and explore the significance of the results of the work).

**Conclusions**

**Appendices** (if necessary).

**Acknowledgments** (collate acknowledgements in a separate section at the end of the article before the references. List here those individuals who provided help during the research, e.g., providing language help, writing assistance or proof reading the article, etc.).

## **ESSENTIAL TITLE PAGE INFORMATION**

**Author names and affiliations.** Please clearly indicate the given name(s) and family name(s) of each author and check that all names are accurately spelled. Present the authors' affiliation addresses (where the actual work was done) below the names. Indicate all affiliations with a lowercase superscript letter immediately after the author's name and in front of the appropriate address.

Provide the full postal address of each affiliation, including the country name and the e-mail address of each author.

**Corresponding author.** Clearly indicate who will handle correspondence at all stages of refereeing and publication, also post-publication. Ensure that the e-mail address is given and that contact details are kept up to date by the corresponding author.

**Present/permanent address.** If an author has moved since the work described in the article was done, or was visiting at the time, a 'Present address' (or 'Permanent address') may be indicated as a footnote to that author's name. The address at which the author actually did the work must be retained as the main, affiliation address. Superscript Arabic numerals are used for such footnotes.

**Formats.** Please 'Save as' or convert the images to one of the following formats (note the resolution requirements for line drawings, halftones, and line/halftone combinations given below): EPS (or PDF): Vector drawings, embed all used fonts. TIFF (or JPEG): Color or grayscale photographs (halftones), keep to a minimum of 300 dpi. TIFF (or JPEG): Bitmapped (pure black & white pixels) line drawings, keep to a minimum of 1000 dpi. TIFF (or JPEG): Combinations bitmapped line/half-tone (color or grayscale), keep to a minimum of 500 dpi.

**Please do not:**

- Supply files that are optimized for screen use (e.g., GIF, BMP, PICT, WPG); these typically have a low number of pixels and limited set of colors;
- Supply files that are too low in resolution;
- Submit graphics that are disproportionately large for the content.

**Figure captions.** Ensure that each illustration is followed by a caption. A caption should comprise a brief title (not on the figure itself) and a description of the illustration. Keep text in the illustrations themselves to a minimum but explain all symbols and abbreviations used.

**Citation in text.** Please ensure that every reference cited in the text is also present in the reference list (and vice versa). Any references cited in the abstract must be given in full. Unpublished results and personal communications are not listed in the reference list but may be mentioned in the text. Citation of a reference as 'in press' implies that the item has been accepted for publication.

**AFTER ACCEPTANCE**

Corresponding authors will receive an e-mail requesting the correction of proofs.

We will do everything possible to get your article published quickly and accurately. Please use this proof only for checking the typesetting, editing, completeness and correctness of the text, tables and figures. Significant changes to the article as accepted for publication will only be considered at this stage with permission from the Editor. It is important to ensure that all corrections are sent back to us in one communication. Please check carefully before replying, as inclusion of any subsequent corrections cannot be guaranteed. Proofreading is solely your responsibility.
